Privacy Statement

Our Policy

- Upon consent of an investor to release such information, including authorization to disclose such information to persons acting in a fiduciary or representative capacity on behalf of the investor.

How We Protect Your Privacy Online

Protecting your personal information online is an essential part of our service. For example:

- To the extent that we provide online access to investments in our fund(s), we validate your identity before we allow online access to your accounts.
- Our systems use technologies such as firewalls and encryption to protect your information from others.

How You Can Help Us Protect Your Information
